**PERMISSION TO PARTICIPATE**

WHEREAS the Guardian(s), despite these and other risks, and fully understanding and conveying these risks to the Guest, do hereby grant the Guest permission to participate conditioned upon the Guest abiding by all the safety and park rules as set forth by the Sponsor. Permission to participate may be rescinded by either party upon ten (10) days written notice to the other party. Now therefore, the Guardian(s), in consideration of the Sponsor permitting the Guest to participate, do hereby covenant and agree on behalf of the Guest and themselves, their heirs, executors, administrators, successors, and assigns as follows:

**HOLD HARMLESS AGREEMENT**

As a condition of being allowed to participate or being allowed on the premises of CPX Sports, the Guardian(s) knowingly and voluntarily waive any legal rights that they may have against the Sponsor, the land owner, equipment manufacturers, and distributors, CPX Sports, and its owners, employees, directors, officers and assigns.

The Guardian(s) agree to hold harmless each and all of the above named parties, and to indemnify each and all of the above named parties against any and all claims, actions, suits costs, expenses (including attorneys' fees), damages, and liabilities arising out of, connected with, or resulting from the Guest participating. The Guest understands that any incident or injury that may occur at CPX Sports must be reported immediately to a member of management and that reporting an incident in no way implies any responsibility or liability on the part of CPX Sports for said incident.

This Hold Harmless Agreement shall continue in effect notwithstanding the fact that "Permission to Participate" may have been rescinded or that the Guest no longer participates. Any Person knowingly presenting false information in an application is guilty of a crime and may be subject to fines and confinement in prison. The Guardians also grant CPX Sports the right to use the guest likeness in any form for promotional purposes.

**FINANCIAL RESPONSIBILITY**

The Guardian(s) understand that they are fully liable and financially responsible for Medical assistance and for the equipment issued /rented to the Guest. The Guardian(s) agrees to fully replace any lost or damaged equipment so issued/rented to the Guest within five (5) days from the date of participating.

### SAFETY RULES:

1. **SAFETY GOGGLES MUST BE WORN AT ALL TIMES.** Players must wear goggles whenever they leave Central Park area. At no time will a player be allowed to break the seal of the goggle from the eyes. Only goggles specifically approved for paintball are allowed. Guests must immediately report rental goggle lens cracks to the Referee or Equipment Room staff. Any goggle lens that has a crack is not allowed.
2. **NO SHOOTING AT THE NECK OR HEAD.** Players may never intentionally fire at another player's head.
3. **DO NOT SHOOT THE WILDLIFE.** Anyone caught shooting the wildlife will be immediately ejected from the park.
4. **NO BLIND FIRING.** Players must always be looking at their targets.
5. **NO SHOOTING INTO OR OUT OF CENTRAL PARK, NEUTRAL ZONES, OR PARKING AREAS.**
  - Players may never discharge their markers anywhere with the exception of the Target Range or the particular field that their game is being held on.
  - Barrel socks are required at all times and may only be removed at the Target Range or on the instruction of a Referee on the playing field.
  - Only products manufactured with the intent of being a barrel sock may be used. Squeegees and other such items may not be used.
  - Dry firing is not allowed in Central Park.
6. **NO CLIMBING OF TREES, STRUCTURES, OR VEHICLES.** Players may never climb any trees; go through any windows, onto any structures or into, on top of, or under any vehicles.
7. **NO PHYSICAL CONTACT.**
  - Players may never touch another player or his equipment. Any fighting will result in Police Action being taken.
  - Remember it's just a game.
8. **NO UNAUTHORIZED EQUIPMENT.**
  - Players are not allowed to bring onto the playing field equipment deemed to be unsafe or inappropriate by the field operator.
  - Players are not allowed to use ANY gun that has an enhanced trigger mode. All guns must be actual semi-automatic. One complete trigger pull for each round fired. This includes but is not limited to Auto Response Triggers, Ramping boards, etc.
  - Players are not allowed to wear metal cleats.
  - Players are NEVER ALLOWED to bring onto the field knives of any size, tools of any sort, machetes, axes, hatchets, paint mines, multiple paintball launchers, pyrotechnics, smoke grenades, or any type of firearms or explosives.
9. **AVOID FIELD HAZARDS.** Players should avoid all obvious hazards such as fences, ruts and vines. Players should report any hazards to CPX staff.
10. **CONSTRUCT NO BOOBY TRAPS.**
  - Players may never construct anything that will hinder the movement of other players.
  - Players are not allowed to construct any sort of barricades or bunkers.
  - Players may not alter any natural or man-made features.
11. **NO ALCOHOL OR ILLEGAL DRUGS ARE ALLOWED ON THE PROPERTY.** Any player caught with either will be asked to leave the premises without any refund and the authorities will be notified.
12. **TOBACCO IS ALLOWED IN DESIGNATED AREA ONLY!** Smoking is permitted only in the designated smoking area located just to the north of the skate park bleachers. Guests are not permitted to smoking in any other locations. Guests found smoking outside this area will be asked to extinguish the smoking materials and may be asked to leave the park.
13. **NO VERBAL ABUSE.** No profanity, name-calling, or slurs against anyone's race, color, religion, national origin or family members will be tolerated. Players with nicknames that are suggestive in nature should not be used.
14. **NO PHYSICAL OR VERBAL ABUSE.** Any verbal or physical abuse of any other park guest or park employee will result in immediate ejection from the park. CPX Sports reserves the right to involve the police as they see fit.
15. **ALL PAINTBALL MARKERS MUST HAVE THE TANK DISCONNECTED AND BARREL SOCK ON WHEN BROUGHT INTO THE MAIN BUILDING.**
16. **DO NOT ATTEMPT TO REMOVE ANY COMPONENTS FROM THE RENTAL EQUIPMENT.**
  - Players are never allowed to remove any parts or components from the rental equipment.
  - This includes, but is not limited to, Tanks, barrels, or hoppers.
  - CPX Tanks cannot be placed on personal equipment.
17. **DO NOT LEAVE GUNS OR TANKS IN DIRECT SUNLIGHT.**
18. **REFEREE DECISIONS ARE FINAL.**
  - Players are NOT allowed to argue with any referee.
  - Any call is final and may be discussed only at the END of the game.
  - Any violation of this rule could result in the player being ejected and/or banned from the park.
  - Remember, it's only a game.
19. **UNSAFE ACTS/ UNSAFE CONDITIONS.** Any guest whose actions jeopardize the safety of themselves or others will be ejected from the park with no refund being issued. Intentional violators may also be banned from returning to CPX Sports in the future.
20. **PHOTOGRAPHY ON THE PLAYING FIELDS IS PROHIBITED.** No personal photo or video equipment is allowed on the playing field at any time.
